Born on Februar 6, 1968, in the city of Ludwigshafen / Rhein, in the country of Germany


For **EMERGENCY PERMISSION FOR POLITICAL ASYLUM** in

to be granted.

Mr. Andreas Klamm, is since 1984 working as journalist, TV journalist, news reporter for press, television, radio, online magazine, newswire, newspaper and since 1993 also working as a nurse R.N / RGN.

Since December 29, 2006 German authorities from the state medical insurance refuse Mr. Andreas Klamm to have any kind of medical treatment although after accidents in 1994, 1995 he is disabled and suffers from chronic diseases. He made the payment for the state medical insurance. Because Mr. Klamm published information on TV, the internet and newspaper about the violations against the human rights in Germany, there is a concern, that this could be related to social political and political reasons. Therefore I do support and ask to grant THE EMERGENCY REQUEST FOR POLITICAL ASYLUM and to grant Mr. Andreas Klamm a life in a country where love, liberty, peace and justice reigns and to support him with the required medical treatment. The refusal of any kind of medical treatment is against the ARTICLE 25, INTERNATIONAL DECLARATION OF THE HUMAN RIGHTS BY THE UNITED NATIONS, NEW YORK, 1948. A similar incident happened already in May 2006 and another incident happened already some years ago. Therefore I do believe that the health, life, rights and safety of Mr. Andreas Klamm is not granted in Germany. Therefore I do support THE EMERGENCY REQUEST FOR POLITICAL ASYLUM by Mr. Andreas Klamm in the UK, alternativley in the USA or in both countries.
